- 4. Application must be accompanied by Advance Authorisation (s) in original.
- 5. FOB value of export for the purpose of V.A shall be arrived at after excluding the Foreign Agency Commission, if any. This provision shall be applicable for authorizations issued on or after 1.4.2008.
- 6. Authorisations should have been issued by the same RA.
