AGENDA NOTE FOR CONSIDERATION OF THE APPROVAL COMMITTEE

a) Proposal: -

Inclusion of additional items in the LOA under broad banding with Revision of Projection for five years.

b) Specific Issue on which decision of UAC is required: -

Approval for inclusion of additional items viz. Tablets (As per Annexure), Capsules (as per Annexure), Syrups (as per Annexure), External preparations (as per Annexure), Surgical (masks, PPE Kits as per Annexure attached), Inhalers, Rota caps and Gel under broad-banding in the LOA with Revision of Export/Import Projections

c) Relevant provisions: -

In terms of Rule 19(2) of SEZ Rules, 2006.

d) Other Information: -

M/s Glowide Pharmaceuticals Pvt. Ltd. has been granted Letter of Approval No. MIHAN-SEZ/Unit-03/LOA-03/AM 2020/248 dated 22.08.2020 for Trading Services i.e. Medicine items ointments, Pharmaceutical Dusting Powder, Tulle Dressings, Cosmetic Cream and Cosmetic Powder at Ground Floor, South Wing, C-Block, Central Facility Building, MIHAN SEZ. The unit has commenced their operation w.e.f. 30.09.2020. The validity of LOA is upto 29.09.2025. The unit vide their letter dated 8.10.2020 & 27.10.2020 has stated that:-

- (i) They have been granted LOA dated 22.08.2019 for trading activities of Medicine items Ointments, Pharmaceutical Dusting Powder, Tulle Dressings, Cosmetic Cream and Cosmetic Powder.
- (ii) They have applied for broad-banding of items in the LOA viz. Tablets, Capsules, Syrups, External preparations, Surgical (Masks, PPE Kits, Inhalers, Rotacaps, Gel.
- (iii) This office vide letter dated 16.06.2020 granted permission to include the said items in the LOA subject to the condition that the said items can be exported as per the current DGFT policy for export enforced.

- (iv) DGFT has also amended their export policy of personal protection equipment's/masks and as per the revised policy vide Notification No.36/2015-2020 dated 6.10.2020 all types of Masks including N95/FFP2 are allowed to be freely exportable.

The unit has requested to re-instate the additional items as approved vide this office letter dated 16.06.2020 including Masks as approved by DGFT as per their revised policy for exports.

It may be mentioned that the unit vide letter dated 9.6.2020 requested for inclusion of additional items viz. Tablets, Capsules, Syrups, External preparations, Surgical (Masks, PPE Kits, Inhalers, Rotacaps, Gel. This office vide letter dated 16.06.2020 granted permission for inclusion of additional items under broad-banding of items subject to the conditions that this approval will be conditional & as per the current DGFT Policy for export enforced.

Subsequently, the permission dated 16.06.2020 was withdrawn vide this office letter dated 25.06.2020 due to restriction on exports of Masks /PPE Kit etc. by the Govt.

The DGFT vide Notification No. 36/2015-2020 dated 6.10.2020 has removed restriction on N95/FFP2 masks or its equivalent and has made it under category of 'Free'.

The unit has submitted the revised Foreign Exchange Balance Sheet consequent upon broad-banding of items. The details are as follows:-

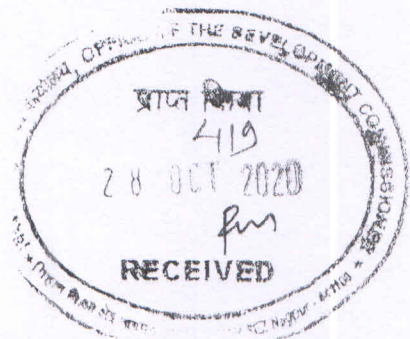
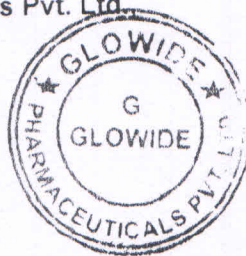

(E) In exercise of powers conferred by Section 3 of the Foreign Trade (Development & Regulation) Act, 1992 (No. 22 of 1992), as amended, read with Para 1.02 and 2.01 of the Foreign Trade Policy, 2015-20, the Central Government hereby makes following amendment in the **Notification No. 29 dated 25.08.2020** amending the Schedule 2 of the ITC (HS) Export Policy 2018 related to the export of Personal Protection Equipments/Masks, as under:

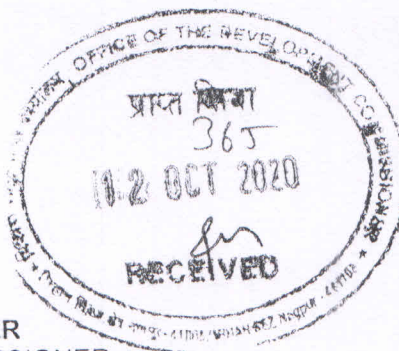

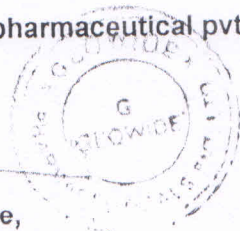
