The committee, after deliberation, decided to approve the List of Goods M/s. Patanjali Ayurved Ltd., for authorized operation as per Annexure - A.

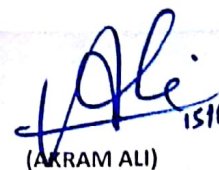
Agenda No.4- Application of M/s. ESSEM Compliance Solutions Pvt. Ltd. for approval of additional list of services
