Special Note:

Failure of the Developer to erect boundary wall of the prescribed specification and absence of proper security on the Gates, inspite of repeated advice from the office, was brought also the attention of the Chairmen and other members of UAC. The Chairmen strictly directed the representative of the developer to immediately rectify these defects and also to install CCTV cameras in sufficient number at each permitted Gates immediately failing which action against them will be initiated as per relevant Rule. The Developer was directed to makes it submission within three days in writing for rectifying the defect.
