The decisions taken during the meeting are as under.

**Agenda No.1- Confirmation of the minutes of the last meeting.**

The committee confirmed the minutes of last meeting held on 30.03.2017.

**Agenda No.2- Application of M/s. Indamer Technics Pvt. Ltd., issue of LoP for setting up a new unit.**

After deliberation, the committee approved the proposal of M/s. Indamer Technics Pvt. Ltd., for establishing 'MRO Service Center for various types of Aircrafts' at Plot No. 2A, 2B, 2C MIHAN-SEZ, subject to the condition that the applicant unit will furnish revised land allotment letter issued by Developer, showing that 20 feet wide stretch of land, 'wherever the boundary of the allotted land coincides with SEZ boundary, has been excluded from the land allotted to the applicant. This condition must be complied within 30 days of issue of LoA failing which LoA will automatically stand cancelled on the expiry of this time period.

**Agenda No.3- Application of M/s. Patanjali Ayurved Ltd., issue of LoP for setting up a new unit.**

After deliberation, the committee approved the proposal of M/s. Patanjali Ayurved Ltd., for establishing 'Manufacturing and Processing of Food and Herbal Products' at Sector No. 12A, 16, MIHAN-SEZ, subject to the condition that the applicant unit will furnish revised land allotment letter issued by Developer, showing that 20 feet wide stretch of land, 'wherever the boundary of the allotted land coincides with SEZ boundary, has been excluded from the land allotted to the applicant. This condition must be complied within 30 days of issue of LoA failing which LoA will automatically stand cancelled on the expiry of this time period.
