**Agenda No.1- Confirmation of the minutes of the last meeting.**

The Committee confirmed the minutes of last meeting held on 06.11.2020.

**Agenda No.2- Application of M/s Tata Advance Systems Ltd. – inclusion of additional items in the LOA under broad-banding.**

After deliberation, the Committee deferred the proposal for further examination.

**Agenda No.3- Application of M/s. Pravesh Exports Pvt. Ltd.- inclusion of additional items in LOA under broad-banding .**

The Committee was informed that import of Green peas ITC HS 07131020 is restricted as per DGFT Notification dated 28.3.2020. In terms of Rule 27(1) of SEZ



Rules, 2006 " A unit or Developer may import or procure from DTA all types of goods including capital goods, raw materials etc. required for authorized operations except prohibited items under ITC(HS) classification of Export and Import items".

After deliberation, the Committee approved the inclusion of additional items viz. Fried Peas (ready to eat) under broad-banding in Letter of Approval dated 07.10.2013 in terms of Rule 19(2) of SEZ Rules, 2006 .

**Agenda No.4-      Application of M/s. Infosys Ltd. (Co-Developer)- approval of additional list of services required for authorized operations.**

After deliberation, the Committee approved the additional list of services viz. Asset Management Services, Developer and Supply of Contents Services, Goods Transport Agency Services, Information Technology Software Services, Survey and Map Making Services, Transport of goods services, Construction Services, SEZ Online Services, Transport Passengers by Air, Accommodation Services and Management and Business Consultant Services required for authorized operations.

**Agenda No.5-      Application of M/s. Infosys Ltd.- approval of additional list of services required for authorized operations.**

After deliberation, the Committee approved the additional list of services viz. Architect Services, Cargo Handling Services, Computer Network Services, Goods Transport Agency Services, Transport of goods Services, Online Information and Database Access Services, Air Travel Agent Services, Rail Travel Agent Services, Travel Agent's Services, Business Support Services, Transport Passengers by Air, Accommodation Services, Management and Business Services required for authorized operations.

**Agenda No.6-      Application of M/s. HCL Technologies Ltd. (Co-Developer).- approval for installation of ATM Facility at Campus**


After deliberation, the Committee approved the proposal of installation of ATM facility at campus of M/s HCL Technologies Ltd. (Co-Developer) subject to condition that the Co-Developer as well as ATM service provider will not be eligible for any

exemption, drawback, concessions or any other benefit available under Section 7 or Section 26 of the SEZ Act, for creating or operating such facility.

for the block period 2016-17 to 2020-21**
